OUR MISSION AND VISION

THE NEED

From the pine forests of our Cascade foothills to the working ranches and farms along the Crooked River and in Madras, the Deschutes Land Trust is conserving land in Central Oregon at a time when the pressures on our human and natural communities are intense.

As our economy continues to diversify from farming, ranching, logging, and other natural resource industries towards tourism, recreation, and technology, we create new opportunities and challenges. Population growth also continues to change the face of our region. This growth accelerates development, increases the need for housing and transportation options, strains natural resources, and changes our quality of life and amazing access to the outdoors. It also enriches our region as people from many different backgrounds work to build community and connect to the outdoors in many different ways. When these population shifts and economic changes are combined with climate change, they place enormous pressure on our region's life-sustaining resources: clean air, clean water, and native plants and animals. The stakes are high. Here in Central Oregon, how will we protect the land we need to clean carbon from the air? How will we provide sufficient clean water for agriculture, people, and the native plants and animals that need it to survive? How do we build communities that coexist with wildfire? How do we address the high demand for outdoor access in an equitable way?

At the Deschutes Land Trust, we don't have all the answers, but we do know that one key to a better future for all of us is conserving and caring for the land. Conserved lands that are vibrant, connected, and strong in the face of a changing climate are also vital for plants, animals, and people. Together we can build a future where our healthy natural areas are inextricably linked to the wellbeing of all Central Oregonians.

- All people have an opportunity to meaningfully connect with this place, so that together we can build an interconnected community of people committed to protecting and caring for the lands we all love.


Collaboration

GOALS + STRATEGIES



Goal 1

Conserved lands throughout Central Oregon provide climate resilience, protect vulnerable habitats and species, support ecological integrity, and foster overall community connection.

Strategy 1:

Protect lands that make our communities and native wildlife and plants stronger in the face of a changing climate.

Strategy 2:

Protect lands that preserve ecological integrity, connect habitats, and support vulnerable species.

Strategy 3:

Protect lands for cultural significance, community health, and other community values.



Goal 2

The Land Trust models and fosters an ethic of inclusive stewardship by restoring priority habitats, providing opportunities for community connection, and maintaining the resilience of our protected lands in perpetuity.

Strategy 1:

Implement identified restoration priorities, using progressive, scientifically robust, ecologically-sound techniques.

Strategy 2:


Work with the Confederated Tribes of Warm Springs to collaborate on management of Land Trust protected lands; to identify, protect, and increase access to sites that support traditional uses; and to increase our understanding and incorporation of traditional ecological knowledge.

Strategy 3:

Engage our community in caring for the land—both on and off Land Trust protected lands—to foster a conservation ethic.

Strategy 4: Responsibly care for Land Trust protected lands.





Goal 3: People throughout Central Oregon are connected with and inspired to care for the land and waters of our region.

Strategy 1:

Engage, mobilize, and expand diverse constituencies of donors, volunteers, supporters, and ambassadors so they feel connected with and invested in our work.

Strategy 2:

Maintain and expand advocacy and other partnerships to increase awareness, leverage funding, extend limited resources, and further the mission of the Land Trust.

Strategy 3:

Deepen and grow relationships with diverse communities throughout Central Oregon.

Strategy 4:

Increase inclusivity of Land Trust programs and properties so all people can access them equitably.

Goal 4: Deschutes Land Trust is well known, engaged with, and broadly supported by the community—a household name and a community institution.

Strategy 1:

Elevate the Land Trust's profile through comprehensive strategic communications and engagement.

Strategy 2:

Demonstrate our conservation leadership at the local, regional, state, and national levels.

Strategy 3:

Develop a culture of philanthropy across the entire organization, where everyone embraces their role in helping to bring relationships and resources to the land trust.

Strategy 4:

Diversify streams of revenue and expand individual, corporate, foundation, and public funding.



Goal 5: Deschutes Land Trust attracts, retains, and develops the diverse talent needed to implement its strategic plan and deliver its mission.

Strategy 1:

Invest in building a collaborative, strengths-based, teamoriented organizational culture that values questions, diverse perspectives, and continuous learning.

Strategy 2:

Ensure the Land Trust has the needed staff skills and capacities to execute the strategic plan, and provides an equitable, flexible, and inclusive work environment that promotes work/life balance and employee satisfaction.

Strategy 3:

Invest in strategic Board recruitment and Board development, so that Board members are fully informed and effectively engaged to help achieve the mission of the Land Trust. **Goal 6:** Deschutes Land Trust builds the financial health, systems, and infrastructure needed to implement its strategic plan and deliver its mission.

Strategy 1:

Build, manage, and oversee our financial assets according to their specific purposes and donor intent, while aligning and balancing investment strategies with the Land Trust's core values and need for resources to implement the Strategic Plan.

Strategy 2:

Provide robust funding for ongoing stewardship of Land Trust protected lands through the continued development of stewardship fund resources and other permanent funding sources.

Strategy 3:

Build and maintain our operating reserve to a minimum of three months of the annual operating budget.

Strategy 4:

Invest in up-to-date business tools, systems, equipment, and infrastructure that support organizational effectiveness and environmental sustainability. The Deschutes Land Trust conserves and cares for the lands and waters that sustain Central Oregon, so local communities and the natural world can flourish together for generations to come.
